

JURIST: Dennis Alan Nawrocki, an Art historian of Realism, modern, and contemporary art, serves as an adjunct faculty at Wayne State University, (WSU) Detroit. He has held museum positions at the Detroit Institute of Arts (DIA), University of Michigan Museum of Art, Ann Arbor, and the Museum of Contemporary Art Chicago. His exhibition credits include "Kick out the Jams: Detroit's Cass Corridor 1963-1977, 1980 at the (DIA), "Dada and Surrealism in Chicago Collections," MCA, 1984: "grounded: Sculpture on the Floor", (UMMA) 1990 and "up from the streets Detroit Art from the Duffy Warehouse collection. (WSU, 2001. He Directed Center Galleries at Detroit's College for Creative Studies (CCS) from 1990-1998, while teaching art history in the Department of Liberal Arts at (CCS) 1990-2005. Author of Art in Detroit Public Places 1980, 1999, 2008, and a freelance critic. Nawrocki has reviewed national and international exhibitions for Art in America, sculpture, American Ceramics, New Art Examiner in Chicago, and the Metro Times Detroit. Recently he has joined Essay'd, an online project (essayd.com) by area writers publishing profiles of regional artists 2015 to present.

Entries

Entries accepted: drawing, colored pencil, painting, all mediums, hand made jewelry, printmaking, photography, sculpture, and ceramics.

Entry Fee

An artist may submit up to eight entries. There is a non-refundable fee of \$35.00 for the first two, and \$10.00 for each additional entry. Please make check payable to the **Livonia Arts Commission**.

CD Entries

All entries must be submitted as digital image on a CD, in a jpg format, 300 dpi, with one of the dimensions being 7 inches. **IMAGES SHOULD HAVE THE TITLE OF THE ARTWORK** precede the jpg file: e.g. Sunflowers.jpg. Artist's name must be on the back of the CD. For 3D artwork, send 2 pictures. Please place labels or titles of artwork on a separate paper, not on the CD.

Presentation Requirements

Accepted entries must be ready for presentation. Framed works must be ready for hanging with appropriate glass or plexiglass and hanging wire. Unprepared works cannot be accepted. Affix a label on back of work identifying artist and title.

Rights and Reproductions

The Livonia Arts Commission reserves the right to photograph and reproduce all entries accepted for the exhibition, regardless of the copyright, for the sole purpose of the exhibition catalog and publicity for the show.

The Livonia Arts Commission and the Robert & Janet Bennett Civic Center Library will exercise all reasonable care with your original artwork. However, the Livonia Arts Commission and the Robert & Janet Bennett Civic Center Library, its directors, members, volunteers or anyone connected with the exhibition will not be responsible for loss or damage. It is suggested that the artist carry their own insurance.

Agreement

Submission of a work to the juror shall constitute an agreement to comply with all the conditions set forth in this prospectus. The juror reserves the right to reject any work not accurately represented by the CD image. The decision of the juror is final. Only artists with accepted work will be notified of the juror's decision. All accepted work will remain as placed by the installation committee and may not be withdrawn before the close of the exhibit.

Delivery For Final Judging

Accepted entries must be HAND DELIVERED to the Livonia Fine Arts Gallery, located on the 2nd floor of the Robert & Janet Bennett Civic Center Library, 32777 Five Mile Road (E of Farmington Rd, Southside of Five Mile Rd.) on Saturday, September 29th, 2018 between 10 a.m. and 12 noon.

Sales

A 35% commission will be charged on all sales made during the exhibition.

Eligibility

Participation is open to all artists 18 years and older, living or working in Michigan. Works in all mediums will be accepted provided they have not been shown in the Exhibition of Fine Arts before. Due to the limitation of space, framed entries larger than 42" high or wide cannot be accepted. Free standing sculptures no more than 60" in any direction will be accepted. Due to the location of the exhibition, nudes will not be accepted for jury.

Entry Procedure

Entries will be juried from digital CD only. NO SLIDES OR PHOTOS WILL BE ACCEPTED. Complete Entry Form and Juror's Results Card. Type or print your name clearly as you wish it to appear in the program. Send CD, JPG, entry form and fee to:
